Report on Activities in FY2023

General Workshop (August 8, 2023 at Sakai City Industrial Promotion Center; August 23 to September 2023 by online distribution)

Visiting Associate Professor Tatsumi Mariko at the Research Center for the Diversity Research Environment, Osaka Metropolitan University, also representative of Hito-Care Work Lab., gave a lecture on "Fathers' Parenting and Gender." Participants learned about the role of gender in parenting that society has created and the historical background of Japan in this regard. The lecture also provided an opportunity to learn about the differences in parenting practices between Japan and other countries and think about the future of parenting in Japan.



Gathering to Protect Human Rights (December 3, 2023 at Sakai City General Welfare Hall)

In the first part, an award ceremony was held to commend 20 winners in the "My Human Rights Message" essay contest, selected from among 2,688 entries. Of them, four award-winners read their essays on stage, leaving a deep impression on the audience.

The second part was a screening of the movie "A Silent Voice." It is a story of the growth of young people who, while facing themselves and their classmates, learn to accept the many differences of those around them and accept each other. The movie led the audience to think about the importance of respecting diversity, their understanding of people with disabilities, and the issue of bullying.

The 44th Essay Contest "My Human Rights Message" Award-winning Entry

A Wall that Obstructs (First-year high school student)

I hope you do not think I am incapable of anything because I have a disability. My disability is what makes me unique and allows me to work harder than others.

Since I am hard of hearing, I feel that the world often thinks that I am unable to communicate or understand what is being said. I communicate by reading the lips of the person I am talking with while hearing the voice through my hearing aids. If I can do these two things, I can almost always understand what is being said. However, it is often difficult for me to understand at once what someone who I have never met is saying. I cannot read their lips because I am seeing them for the first time. Whenever this happens, I ask the person to say it again. At that point, people react in many different ways: some mistake my hearing aids for earbuds, while others stop interacting with me, ignore me, or become reluctant to deal with a person with a disability. These are common reactions and I do not mind, but they can cause me some trouble when I play table tennis.

I started practicing table tennis in earnest when I was in the first year of junior high school. When I was in elementary school, I only played table tennis with my grandfather for fun, so I had little trouble in communicating. In time, I wanted to get better at table tennis and practice in earnest, so I began attending table tennis training sessions at the gym of a local elementary school. Since the training was organized by the table tennis federation, I thought that I would be stronger if I practiced there. However, when I tried to get people with normal hearing to be my practice partners, I could not understand what they were saying because they did not make eye contact with me, or the practice session ended without any communication at all. Each time, I wondered if I was being avoided because I was hard of hearing, or if they thought I could not communicate because I could not hear. Eventually, I began to practice in silence, not speaking a word. Since it was like that, of course I could not win the practice matches. The results showed that I was not developing my skills. At one point, I was surprised to find myself thinking, "I want to win against people with normal hearing at any cost."

I wondered, on second thought, if they were just going along with my practice because I am hard of hearing and they had no choice. If that was the case, I thought I would make efforts so that they would interact with me no differently than they would

with a person with normal hearing. I watched and studied many videos to improve my table tennis skills, and I actively talked to them to hear what they were saying as much as possible. I put all my energy into practicing so that they would want to be my practice partner at least once in the gym. Then they started to talk to me. Just by being asked to play together with others, I began to enjoy table tennis very much.

I know that people with normal hearing do not avoid practicing with me because of the difference in table tennis skills. However, actually, there are those who will interact with people who are hard of hearing if they talk to them, but are not quite sure how to interact with them. In many cases, such people seemed to avoid me because they assumed that I, a hard of hearing person, could not communicate with them or they did not know how to practice with me. There is still a lack of understanding of people who are hard of hearing. If that is the case, I would like to think of my own way to show myself and become someone that people would think, "I want to practice with that person."

About LGBTQ+ (Sexual Minorities)

What is LGBTQ+?

This refers to people who are recognized as a minority in their sexuality, such as those who have romantic feelings for members of the same sex or who are uncomfortable with their physical sex. According to several private surveys conducted in the country in recent years, LGBTQ+ people are estimated to make up approximately 3–8% of the total population.



Act on the Promotion of Public Understanding of Diversity of Sexual Orientation and Gender Identity came into effect

The act was enacted with the aim of contributing to the creation of a society that is tolerant of diversity in sexual orientation and gender identity.

The basic principle is that all citizens, regardless of their sexual orientation or gender identity, are to be respected as irreplaceable individuals who equally enjoy fundamental human rights.



- *Sexual orientation...Orientation regarding sex or gender as the object of romantic or sexual feelings
- *Gender identity···Awareness of the existence or non-existence or degree of identity regarding the perception of the gender to which one belongs


Information ethics
